All vehicles shall meet the requirements of Arkansas Department of Transportation Specifications attached to and made a part of this bid.

Contract may be renewed upon mutual agreement of the parties, but shall not exceed limitations allowed by Arkansas State Procurement Law.

All bidders should complete and return the Eligible Bidder Certification (Attachment A), Disclosure Form (see Page 2 of Standard Bid Conditions – Item 18) and Restriction of Boycott of Israel Certification issued with this bid. A current copy of the DFA Illegal Immigrant Contractor Disclosure Certification (see Page 2 of Standard Bid Conditions – Item 17) should also be submitted with bid. These forms are kept on file and remain current for one year from date of submission. Forms do not need to be submitted again, during that time, unless there is a status change. Bid prices shall include delivery of all vehicles to the Arkansas Department of Transportation at the F.O.B. location shown on the Bid Sheets and shall include the warranty and service requirements stated in the specifications.

Any variation from each specification must be shown on the face of the bid or listed on a separate sheet of paper and attached to bid. This sheet shall be labeled as such.

Bid Bond in the amount of \$1,000 required of all bidders at time of bid opening or bid will be rejected. <u>Personal and company checks are not</u> <u>acceptable as Bid Bonds</u>. See Condition 4 on page 1 of Standard Bid Conditions.

Performance Bond in the amount of 5% of the total awarded to the respective bidders must be furnished within 10 days after receipt of notice of intent to award as a guarantee of delivery in accordance with the specifications and within the time established in the bid. <u>Personal and company</u> checks are not acceptable as Performance Bonds. See Condition 3 on page 2 of bid invitation.

Additional Bonding Requirement: If additional units are purchased from this contract, a separate Performance Bond will be required under the same conditions as stated in this Bid Invitation.

Bidder shall specify guaranteed delivery date for all vehicles bid on in the space provided under each item number. Successful bidder shall furnish Warranty Data for each vehicle delivered. The Warranty Data shall contain all necessary information such as motor and/or serial numbers and shall be signed by the selling dealer at the time vehicle is delivered to ARDOT. Certificate of Origin, Federal Excise Tax Exemption Certificates, Odometer Disclosure Statement and five (5) copies of the Invoice for each vehicle to be furnished to Equipment & Procurement Division, P.O. Box 2261, Little Rock, AR 72203.

Each vehicle shall be completely serviced, cleaned and thoroughly inspected (in accordance with manufacturer's required or recommended predelivery service) just prior to delivery to the Arkansas Department of Transportation.

No dealer advertisement shall be affixed to the vehicle.

The successful bidder shall furnish copy of Operator's Manual published by vehicle manufacturer with each vehicle delivered.

Any equipment furnished on vehicles purchased under this specification for which "Federal Register Standard" has been established at time of delivery shall comply with the requirements of applicable standard and all equipment required by said standard shall be furnished whether or not it is specifically mentioned in this specification. The Arkansas Department of Transportation reserves the right to test drive make and model of vehicles bid on prior to contract being awarded. Samples may be demonstrator models with equipment similar, but not necessarily identical, to that listed in this specification.

Bids and Specifications are available on-line by going to the ARDOT Web Site – <u>www.ardot.gov</u> and clicking on "Bids/Contracts". Tabulations will also be available at this site after award of bid/contract. If you have any questions, call this office at 501-569-2667.

<u>Cooperative Purchasing</u>: Other tax-supported entities* in Arkansas (cities, counties, state agencies, school districts, etc.) may purchase from this Contract on an individual basis under the same specifications and conditions, and at the pricing set forth by each vendor, all at the discretion of each vendor in each case. Prices could be reduced by a vendor for minor alterations in conditions (changing order quantities, deleting options, etc.) as agreed by both parties, but could not be raised above the contract bid price except for any additional freight charges. Vendors would not be required to sell to any such entity under this contract, and those entities would not be obligated to purchase from the contract.

Each entity wishing to purchase from the contract must make contact directly with the appropriate vendor(s). The Department of Transportation shall remain "out of the loop" for such transactions: all contact, orders, invoices, payments, etc. regarding such transactions must take place exclusively between the tax-supported entity and the vendor. The ARDOT shall be held harmless of any and all liability arising from such transactions.

STANDARD BID CONDITIONS

- 1. **GENERAL:** Any special terms and conditions included in the invitation for bid override these standard terms and conditions. The standard terms and conditions and any special terms and conditions become part of any contract entered into if any or all parts of the bid are accepted by the Arkansas Department of Transportation (ARDOT).
- ACCEPTANCE AND REJECTION: ARDOT reserves the right to reject any or all bids, to accept bids in whole or in part (unless otherwise indicated by bidder), to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the State.
- 3. **PRICES:** Unless otherwise stated in the Bid Invitation, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified (feet, each, lbs., etc.), (3) prices must be F.O.B. destination specified in bid, (4) prices must be firm and not subject to escalation, (5) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit prices shall govern. Discounts from bid price will not be considered in making awards.
- BID BONDS AND PERFORMANCE BONDS: If required, a Bid Bond in the form of a cashier's check, certified check, or 4. surety bond issued by a surety company, in an amount stated in the Bid Invitation, must accompany bid. Personal and company checks are not acceptable as Bid Bonds. Failure to submit a Bid Bond as required will cause a bid to be rejected. The Bid Bond will be forfeited as liquidated damages if the successful bidder fails to provide a required Performance Bond within the period stipulated by ARDOT or fails to honor their bid. When a bidder claims and can show clear and convincing evidence that a material mistake was made in the bid and was not the bid intended, the bidder may be permitted to withdraw their bid prior to award without forfeiture of bid bond. Cashier's checks and certified checks submitted as Bid Bonds will be returned to unsuccessful bidders; surety bonds will be retained. The successful bidder will be required to furnish a Performance Bond in an amount stated in the Bid Invitation and in the form of a cashier's check, certified check, or surety bond issued by a surety company, unless otherwise stated in the Bid Invitation, as a guarantee of delivery of goods/services in accordance with the specifications and within the time established in the bid. Personal and company checks are not acceptable as Performance Bonds. In some cases, a cashier's check or certified check submitted as a Bid Bond will be held as the Performance Bond of the successful bidder. Cashier's checks or certified checks submitted as Performance Bonds will be refunded shortly after payment has been made to the successful bidder for completion of all terms of the bid; surety bonds will be retained. Surety bonds must be issued by a surety company authorized to do business in Arkansas, and must be signed by a Resident Local Agent licensed by the Arkansas State Insurance Commissioner to represent that surety company. Resident Agent's Power-of-Attorney must accompany the surety bond. Certain bids involving labor will require Performance Bonds in the form of surety bonds only (no checks of any kind allowed). These bonds shall not only serve to guarantee the completion of the work, but also to guarantee the excellence of both workmanship and material until the work is finally accepted and the provisions of the Plans, Specifications, and Special Provisions fulfilled. In such cases, the company issuing the surety bond must comply with all stipulations herein and must be named in the U.S. Treasury listing of companies holding Certificates of Authority as acceptable sureties on Federal Bonds and as acceptable reinsuring companies. Any excess between the face amount of the bond and the underwriting limitation of the bonding company shall be protected by reinsurance provided by an acceptable reinsuring company. Annual Bid and Performance Bonds on file with E & P Division must have sufficient unencumbered funds to meet current bonding requirements, or the bid will be rejected, unless the balance is submitted as set forth above, prior to bid opening.
- 5. TAXES: The ARDOT is not exempt from Arkansas State Sales and Use Taxes, or local option city/county sales taxes, when applicable, and bidders are responsible to the State Revenue Department for such taxes. These taxes should not be included in bid prices, but where required by law, will be paid by the ARDOT as an addition thereto, and should be added to the billing to the ARDOT. The ARDOT is exempt from Federal Excise Taxes on all commodities except motor fuels; and excise taxes should not be included in bid prices except for motor fuels. Where applicable, tax exemption certificates will be furnished by the ARDOT.
- 6. "ALL OR NONE" BIDS: Bidders who wish to bid "All or None" on two or more items shall so stipulate on the face of bid sheet; otherwise, bid may be awarded on an individual item basis.
- 7. **SPECIFICATIONS:** Complete specifications should be attached for any substitution or alternate offered, or where amplification is necessary. Bidder's name must be placed on all attachments to the bid.
- 8. **EXCEPTIONS TO SPECIFICATIONS:** Any exceptions to the bid specifications must be stated in the bid. Any exceptions to manufacturer's published literature must be stated in the bid, or it will be assumed that bidder is bidding exactly as stated in the literature.
- 9. **BRAND NAME REFERENCES:** All brand name references in bid specifications refer to that commodity or its equivalent, unless otherwise stated in Bid Invitation. Bidder should state brand or trade name of item being bid, if such name exists.
- 10. **FREIGHT:** All freight charges should be included in bid price. Any change in common carrier rates authorized by the Interstate Commerce Commission will be adjusted if such change occurs after the bid opening date. Receipted common carrier bills that reflect ICC authorized rate changes must be furnished.

- 11. **SAMPLES, LITERATURE, DEMONSTRATIONS:** Samples and technical literature must be provided free of any charge within 14 days of ARDOT request, and free demonstrations within 30 days, unless ARDOT extends time. Failure to provide as requested within this period may cause bid to be rejected. Samples, literature and demonstrations must be substantially the same as the item(s) being bid, unless otherwise agreed to by ARDOT. Samples that are not destroyed will be returned upon request at bidders expense. Samples from successful bidders may be retained for comparison with items actually furnished.
- 12. **GUARANTY:** Unless otherwise indicated in Bid Invitation, it is understood and agreed that any item offered or shipped on this bid shall be newly manufactured, latest model and design, and in first class condition; and that all containers shall be new, suitable for storage or shipment and in compliance with all applicable laws relating to construction, packaging, labeling and registration.
- 13. BACKORDERS OR DELAY IN DELIVERY: Backorders or failure to deliver within the time required may constitute default. Vendor must give written notice to the ARDOT, as soon as possible, of the reason for any delay and the expected delivery date. The ARDOT has the right to extend delivery if reasons appear valid. If reason or delivery date is not acceptable, vendor is in default.
- 14. **DEFAULT:** All commodities furnished will be subject to inspection and acceptance by ARDOT after delivery. Default in promised delivery or failure to meet specifications authorizes the ARDOT to cancel award or any portion of same, to reasonably purchase commodities or services elsewhere and to charge full increase, if any, in cost and handling to defaulting vendor. Applicable bonds may be forfeited.
- 15. ETHICS: "It shall be a breach of ethical standards for a person to be retained, or to retain a person, to solicit or secure a State contract upon an agreement of understanding for a commission, percentage, brokerage, or contingent fee, except for retention of bona fide employees or bona fide established commercial selling agencies maintained by the contractor for the purpose of securing business." (Arkansas Code, Annotated, Section 19-11-708).
- 16. NOTICE OF NONDISCRIMINATION: The Arkansas State Highway Commission, through ARDOT, complies with all civil rights provisions of federal statutes and related authorities that prohibit discrimination in programs and activities receiving federal financial assistance. - 12. <u>Cab</u>: Four (4) Door Extended Type Cab complete with insulation and all standard interior trim, dual electric intermittent windshield wipers with washers, factory installed fresh air heater-defroster unit, factory installed electronic AM/FM radio with in-vehicle communication system that pairs to Bluetooth enabled cell phones allowing for hands free operation of the phone, floor covering consisting of manufacturer's standard materials and colors, right and left sun visors, power windows, remote keyless entry, inside rear view mirror and right and left side exterior mirrors no less than 8.5" x 5".
- 13. <u>Seating</u>: Two (2) three (3) person seating capacity bench seats. Front seat to be cloth split bench style with fold-down center arm rest. Rear seat upholstery to consist of manufacturer's standard materials and colors for model and trim level provided. Seat belts shall be provided for all seating positions.
- 14. <u>Air Conditioning</u>: Shall be equipped with factory installed air conditioning and include tinted glass.
- 15. <u>Tilt Steering Column</u>: Factory installed.
- 16. <u>Speed Control</u>: Factory installed automatic speed control.
- 17. Wheels: Five (5) 17" diameter steel disc with no less than 7.5" rim section.
- 18. Tires: Five (5) On/Off Road or All Terrain tubeless radials no less than LT245/70R17 or LT265/70R18, E load range.
- 19. <u>Fuel Tank</u>: Minimum fuel capacity of 29 gallons. Fuel fill hose assembly furnished with fuel tank shall be a minimum of 36" in length to allow attachment to an aftermarket body.
- 20. Front Tow Hooks: Two (2), minimum.
- 21. <u>Lights</u>: Dual beam headlights, parking lights, self canceling directional turn signals with hazard flasher switch, back up lights and front side marker lights. Rear lights to consist of stop and tail lights in addition to directional signals.
- 22. Equipment: Front bumper, front and rear shock absorbers, hub caps, jack and lug wrench.
- 23. <u>Key Fobs</u>: A minimum of two (2) key fobs shall be provided. Key fobs shall provide the following functions at a minimum, lock doors, unlock doors and ignition activation.
- 24. <u>Color</u>: Sherwin Williams F8W2030 Frost White Acrylic Enamel, or equal. Front bumper shall be chrome. Rear bumper, grill, mirrors, wheels and hubcaps as regularly furnished by manufacturer.

C. Service Body:

- 1. <u>Body</u>: Low profile service body normally designed to mount on chassis described above.
- 2. <u>Construction</u>: Electrically welded all steel construction with edges rolled or folded. Body shall have longitudinal members and cross members welded for floor support. Body floor shall be constructed of no less than 12-gauge safety tread plate.
- 3. <u>Dimensions</u>:
 - A. Body Length: 96" 98".
 - B. <u>Body Width</u>: 76" 80".
 - C. <u>Body Height</u>: 35" 40".
 - D. Body Floor To Compartment Top: 19"-24".
 - E. <u>Compartment Depth</u>: 14" 15".
 - F. Floor Width: 48" 51".
- 4. <u>Compartments</u>: Each side of the body shall have a minimum of one (1) vertical compartment in front of the rear wheels, one (1) horizontal compartment over the rear wheels and a minimum of one (1) vertical compartment behind the rear wheels. Vertical compartments shall be full height and have adjustable shelves. Each horizontal compartment shall have an adjustable shelf and dividers. All doors shall be protected from weather and have double panels with flush type handles and locks keyed alike. Doors shall have rubber seals to keep out water and dust.
- 5. <u>Tailgate</u>: Body shall have a hinged tailgate no less than 9" high that opens to floor level with chain or arm support.
- 6. <u>Bumper</u>: Shall have a rear step plate type heavy duty bumper with recess and ball hitch plate. Bumper brackets shall mount to truck frame.
- 7. Lights: Combination tail and directional lights and backup lights to meet ICC regulations.
- 8. <u>Color</u>: Body shall be painted Sherwin Williams F8W2030 Frost White Acrylic Enamel, or equal.

D. <u>Warranty</u>:

- 1. Cab & chassis purchased under this specification shall include manufacturer's standard warranty.
- 2. Body purchased under this specification shall be warranted against defects in material and workmanship for a minimum period of twelve (12) months (365 days) from date unit is placed in operation by ARDOT.
- 3. Warranty shall include all parts and labor cost associated with needed repairs based on defects in material and workmanship.
- 4. It will be the responsibility of the successful bidder to insure that repairs are completed in a timely manner.
- 5. If any warranty literature submitted with the bid conflicts with ARDOT warranty requirements, the conflict(s) shall be specifically noted, corrected and included with the bid or the conflict(s) will be considered an exception to warranty specifications and the bid rejected.
- 6. Recent prior failure to provide warranty-work, parts, replacement parts or service, in a timely manner, for equipment from the same manufacturer or dealer shall be grounds for the rejection of any submitted bid, or for the denial of any otherwise qualified low bidder, whether such failure is attributable to the manufacturer or the dealer of the equipment. For the purposes of this paragraph "timely manner" means a period of time not exceeding thirty (30) calendar days to provide requested warranty-work, parts, replacement parts, or service. For the purposes of this paragraph "manufacturer" means the original manufacturer of the equipment and its successor or successors, regardless of number, and whether acquired by sale, merger, or otherwise. For the purposes of this paragraph "replacement part" means a part redesigned by a manufacturer to correct a design or engineering defect and which replacement part is capable of providing dependable performance in normal operation conditions for its normal service life without failure. Such bid or bids may be rejected by the Department until such failure or failures have been remedied to the satisfaction of the Department and until such manufacturer or dealer is providing such warranty-work, parts, replacement parts, and service in a timely manner.
