#### **ARDOT - STANDARD BID CONDITIONS**

- 1. **GENERAL:** Any special terms and conditions included in the invitation for bid override these standard terms and conditions. The standard terms and conditions and any special terms and conditions become part of any contract entered into if any or all parts of the bid are accepted by the Arkansas Department of Transportation (ARDOT).
- 2. **ACCEPTANCE AND REJECTION:** ARDOT reserves the right to reject any or all bids, to accept bids in whole or in part (unless otherwise indicated by bidder), to waive any informalities in bids received, to accept bids on materials or equipment with variations from specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the State.
- 3. **PRICES:** Unless otherwise stated in the Bid Invitation, the following will apply: (1) unit prices shall be bid, (2) prices should be stated in units of quantity specified (feet, each, lbs., etc.), (3) prices must be F.O.B. destination specified in bid, (4) prices must be firm and not subject to escalation, (5) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit prices shall govern. Discounts from bid price will not be considered in making awards.
- BID BONDS AND PERFORMANCE BONDS: If required, a Bid Bond in the form of a cashier's check, certified check, or surety bond issued by a surety company, in an amount stated in the Bid Invitation, must accompany bid. Personal and company checks are not acceptable as Bid Bonds. Failure to submit a Bid Bond as required will cause a bid to be rejected. The Bid Bond will be forfeited as liquidated damages if the successful bidder fails to provide a required Performance Bond within the period stipulated by ARDOT or fails to honor their bid. When a bidder claims and can show clear and convincing evidence that a material mistake was made in the bid and was not the bid intended, the bidder may be permitted to withdraw their bid prior to award without forfeiture of bid bond. Cashier's checks and certified checks submitted as Bid Bonds will be returned to unsuccessful bidders; surety bonds will be retained. The successful bidder will be required to furnish a Performance Bond in an amount stated in the Bid Invitation and in the form of a cashier's check, certified check, or surety bond issued by a surety company, unless otherwise stated in the Bid Invitation, as a guarantee of delivery of goods/services in accordance with the specifications and within the time established in the bid. Personal and company checks are not acceptable as Performance Bonds. In some cases, a cashier's check or certified check submitted as a Bid Bond will be held as the Performance Bond of the successful bidder, Cashier's checks or certified checks submitted as Performance Bonds will be refunded shortly after payment has been made to the successful bidder for completion of all terms of the bid; surety bonds will be retained. Surety bonds must be issued by a surety company authorized to do business in Arkansas, and must be signed by a Resident Local Agent licensed by the Arkansas State Insurance Commissioner to represent that surety company. - 5. Where applicable, tax exemption certificates will be furnished by the ARDOT.
- 6. "ALL OR NONE" BIDS: Bidders who wish to bid "All or None" on two or more items shall so stipulate on the face of bid sheet; otherwise, bid may be awarded on an individual item basis.
- 7. **SPECIFICATIONS:** Complete specifications should be attached for any substitution or alternate offered, or where amplification is necessary. Bidder's name must be placed on all attachments to the bid.
- 8. **EXCEPTIONS TO SPECIFICATIONS:** Any exceptions to the bid specifications must be stated in the bid. Any exceptions to manufacturer's published literature must be stated in the bid, or it will be assumed that bidder is bidding exactly as stated in the literature.
- 9. **BRAND NAME REFERENCES:** All brand name references in bid specifications refer to that commodity or its equivalent, unless otherwise stated in Bid Invitation. Bidder should state brand or trade name of item being bid, if such name exists.
- 10. **FREIGHT:** All freight charges should be included in bid price. Any change in common carrier rates authorized by the Interstate Commerce Commission will be adjusted if such change occurs after the bid opening date. Receipted common carrier bills that reflect ICC authorized rate changes must be furnished.

- 11. **SAMPLES, LITERATURE, DEMONSTRATIONS:** Samples and technical literature must be provided free of any charge within 14 days of ARDOT request, and free demonstrations within 30 days, unless ARDOT extends time. Failure to provide as requested within this period may cause bid to be rejected. Samples, literature and demonstrations must be substantially the same as the item(s) being bid, unless otherwise agreed to by ARDOT. Samples that are not destroyed will be returned upon request at bidders expense. Samples from successful bidders may be retained for comparison with items actually furnished.
- 12. **GUARANTY:** Unless otherwise indicated in Bid Invitation, it is understood and agreed that any item offered or shipped on this bid shall be newly manufactured, latest model and design, and in first class condition; and that all containers shall be new, suitable for storage or shipment and in compliance with all applicable laws relating to construction, packaging, labeling and registration.
- 13. BACKORDERS OR DELAY IN DELIVERY: Backorders or failure to deliver within the time required may constitute default. Vendor must give written notice to the ARDOT, as soon as possible, of the reason for any delay and the expected delivery date. The ARDOT has the right to extend delivery if reasons appear valid. If reason or delivery date is not acceptable, vendor is in default.
- 14. **DEFAULT:** All commodities furnished will be subject to inspection and acceptance by ARDOT after delivery. Default in promised delivery or failure to meet specifications authorizes the ARDOT to cancel award or any portion of same, to reasonably purchase commodities or services elsewhere and to charge full increase, if any, in cost and handling to defaulting vendor. Applicable bonds may be forfeited.

## MEDIUM DUTY CUTAWAY TRANSIT BUS with Optional ADA Equipment

#### PURPOSE OF SPECIFICATIONS

This item shall be a vehicle suitable for public transportation. The intent for these specifications is to set-forth the minimum performance for a commercial body-on-chassis transit bus. The vehicle shall be a standard production bus, which will be used to transport the general public living in urban and rural areas. When equipped with an optional wheelchair lift and securement devices, this vehicle shall accommodate various seating combinations for both ambulatory and wheelchair passengers and will be required to operate on all types of neighborhood streets and rural roads with frequent starts and stops.

All parts not specifically mentioned which are necessary in order to provide a complete vehicle, shall, at a minimum, conform in strength, quality of material and workmanship to what is provided by the automotive industry generally. All equipment and parts shall be new and conform in strength; quality of material and workmanship to those approved by and generally utilized by the automotive industry and meets all applicable standards.

## <u>Dealer shall have as part of the documentation with receipt of each vehicle, a form with a detailed listing of the warranties on the vehicle, conversion and ordered options.</u>

The vehicle manufacturer must strictly comply with chassis OEM standards and specifications for installation and application of all products, equipment, components, and any other items placed in or upon the chassis. Vehicle and modifications must comply with all Federal Motor Vehicle Safety Standards.

#### CLASSIFICATION OF VEHICLE CHASSIS AND SERVICE LIFE

The most current production year model chassis available shall be used for this vehicle and shall be a minimum 12,500 GVWR on 20' unit and 14,500 GVWR on 22' and 24' units, rating by the OEM to accommodate the final GVWR established for the completed unit by the after-market vehicle manufacturer.

The Department useful life standard established for this vehicle is 5 years/150,000 miles, and the Department requires the like-type model vehicle proposed to be, or have been, tested at the FTA Bus Testing Facility in this category or a higher service life category.

#### A. Principal Specifications:

1. <u>Access Plate</u>: Shall install an access plate above fuel tank to allow easy access to fuel pump sending unit.

- 2. **Air conditioning**: Shall have the largest OEM available BTU system available and have a second unit for rear compartment with a minimum rating of 64,000 BTUs with a minimum three speed fan. Shall be installed following the chassis OEM approved design and installation standards to augment the chassis OEM unit. The additional system shall be a stand-alone system not tied into the chassis OEM system.
- Alignment: Shall have a full and complete front-end alignment performed by an OEM
  approved dealer service center after the manufacturing process has been completed and prior
  to delivery with a copy of the certificate.
- 4. <u>Alternator</u>: Heavy duty OEM, minimum 225 amperage alternator or approved equal.
- 5. Automatic Speed Control: Shall be factory installed.
- 6. <u>Backup Camera</u>: Shall have a commercial grade Rosco STSK4750, Back-up Camera System with 7" Rearview Monitor/Mirror Combo or approved equal in driver's rear view mirror. Shall be a heavy duty system capable of enduring transit environment and camera to be either mounted in a recessed area or have a guard mounted to prevent damage to camera. Camera to be located above the rear window of bus.
- 7. **Battery**: Shall be a dual battery system supplied with heavy-duty commercial type batteries with a minimum 1250 CCAs. The battery storage compartment shall be located in an enclosed compartment either on the side of the vehicle incorporating a sliding tray for ease of access and shall not extend beyond or below a line horizontal to the step well or the battery storage compartment shall be located in an enclosed compartment in the stepwell.
- 8. <u>Body</u>: Shall be either a Fiberglass Reinforced Plastic body (FRP) with incorporated steel structural reinforcements; or an FRP or metal sheeting material attached to a structural safety cage designed to meet all applicable FMVSS requirements. <u>If two or more dissimilar metals are used for the body, the manufacturer must provide adequate protection to prevent electrolysis from damaging the vehicle in any way.</u>
- 9. **Brakes**: Power front and rear disc with four-wheel anti-lock.
- 10. <u>Bumpers</u>: Shall be provided for both front and rear of vehicle. OEM type and style is to be retained in the front. Manufacturer shall install a rear bumper designed and built of a 12-gauge or heavier metal, and mounted to the frame outward from the body so as to protect the rear body panels from a collision at 5 mph or less. The finish shall be anodized aluminum, steel chrome plate, or an OEM standard coating and must compliment the body style and color.
- 11. <u>Chassis</u>: Shall be a dual wheeled truck chassis with a minimum 12,500 GVRW on 20' unit and 14,500 GVWR on 22' and 24' units, OEM rated GVWR adequate to accommodate the final load capacity for passengers and equipment. <u>Bidder shall state type of chassis to be used.</u>
- 12. <u>Cooling System</u>: Heavy duty, including heavy duty, extra capacity radiator, and factory installed coolant recovery system.
- 13. **Door. Ambulatory Front Entrance**: Shall consist of two panels, folding transit type, which provides a minimum width clear center opening of 26" and a minimum height from lower step to door header of 75". Ambulatory door shall have an electrical/mechanical power unit that allows operation by a dash-mounted switch. Door opener shall provide a smooth operation throughout the open and close cycle. Door opener must be designed to allow ease of troubleshooting and field maintenance and shall have an integrated manual backup system in the event of an electrical or mechanical failure. Door shall have an exterior key lock system.

The step and well shall be designed and constructed of corrosion resistant materials with adequate strength and reinforcing to accommodate a 250 lb passenger. Maximum riser height shall be 10" with a minimum tread depth of 8".

- **14. Door. Rear Exit:** Shall have a rear fiberglass door on the back of the body. Shall be accessible from the interior as well as the exterior. Shall have an alarm to alert the driver if door is **not in the locked position**. Shall have a window mounted in the door as well as side windows on each side of door.
- 15. **Drive Shaft**: Shall have a drive shaft loop(s) to prevent a broken shaft from touching the ground or contacting the brake lines.
- 16. **Engine**: Shall be the largest gasoline engine with the highest horsepower rating offered by the OEM chassis manufacturer to accommodate the GVWR of the completed bus.
- 17. **Exhaust**: Engine exhaust system shall be routed to exit the **rear driver's side** of the vehicle to channel exhaust gases away from curbside passengers to the maximum extent possible.
- 18. **Exterior Dimensions**: Dimensions shall be: **Minimum** Width of 96", **Maximum** Height of 115", and **Maximum** Length of 22' for 16 rear passenger unit; 24' for 20 rear passenger unit; 26' for 24 rear passenger unit.
- 19. <u>Fast Idle</u>: Shall provide an Intermotive engine fast idle control or approved equal to permit the driver to increase engine idle RPM to a preset RPM when the transmission is in the PARK position and the parking brake is set. Idle RPM should automatically return to normal when the brake is released or transmission is put into gear.
- 20. <u>Floor</u>: Floor shall be an exterior grade, 7-ply water resistant; plywood being no less than ¾" thickness with underbelly sealed to protect wood from water and road debris and shall be securely fastened to a metal rail sub floor.
- 21. Floor Covering: Floor covering shall be a transit grade vinyl Gerflor or approved equal in standard black finish with a minimum of 1/8" thickness under the passenger seats and as supplied by the OEM in the driver's area. There shall also be a 2" wide white "Standee Limit" strip set into the aisle covering located at the rear of the driver's seat as per DOT regulations.
- 22. <u>Fuel Tank Capacity</u>: Shall have a fuel tank, with a minimum capacity of 40 gallons, located in a protected area under the floor.
- 23. **Grab Rails**: Shall have dual grab rails installed adjacent to the entrance access to aide passengers with boarding and dual grab rails installed in the roof to provide passengers with a secure holding area from front of vehicle to the rear.
- 24. **Heater**: Integral fresh air heater and defroster and shall be augmented by an additional auxiliary rear heater(s) to achieve and maintain an interior temperature of 65° F when the ambient temperature is 0° F. Shall also have a shutoff valve between the engine and rear heater to prevent coolant flow in the warmer months, a decal on body to show the valve location.
- 25. **Insulation**: Shall have fiberglass mats, high-density polystyrene or approved equal, and be used to insulate the entire body, sides, front, rear and roof, achieving a R-5 rating or greater.
- 26. <u>Interior Finish</u>: Shall be a flame retardant fiberglass or vinyl padded material or approved equal, of sufficient thickness and durability to maintain it appearance under heavy usage, and be adequately supported to prevent buckling. Material shall be color keyed to the seat color and be subject to approval by the Department.
- 27. **Kevs**: Shall provide two (2) keys minimum per vehicle.
- 28. License plate brackets: Front and rear.

- 29. <u>Lights, Exterior</u>: Shall provide exterior dome LED type clearance lights to be mounted in a recessed area or shall have an "armor type" protection. All exterior lights, with the exception of the OEM headlights and front turn signals, shall be the LED type including rear parking, brake, turn signal, and backup lights. Shall also provide LED type mid-body and side turn signal lights.
- 30. <u>Lights, Interior</u>: Shall have six (6) passenger and one (1) driver dome mounted courtesy **LED** lights. Step well shall have at a minimum one (1) shielded **LED** light.
- 31. **Manual**: Shall provide an "as built" service manual in an electronic form on a CD that shall be in MS Word or Adobe format.
- 32. <u>Metal and Metal Fasteners</u>: All metal and metal fasteners, including any required nuts and washers, used in the manufacturing process shall be rust and corrosive resistant. Metal and metal coating processes to ensure rust and corrosive resistant properties shall be subject to testing and approval. Metal and metal screws exposed to the outside environment shall be stainless steel or approved equal to the extent possible.
- 33. <u>Mirrors</u>: Shall be <u>power and heated</u> Velvac or Rosco Breakaway Mirror or approved equal with a "breakaway design" with a minimum of 54 square inches of reflective area with one on each side of vehicle and have a convex mirror incorporated on each mirror. Mirrors shall be mounted to minimize road vibration. An interior convex rear view mirror shall be mounted above the windshield to provide the driver with a full view of the bus interior in addition to the OEM day-night mirror attached to the windshield.
- 34. Paint: Bus cab shall be painted the manufacturer's standard white and have a 2" high intensity white 3M Diamond Grade 983 Series reflective type tape stripe down both sides of vehicle just below side windows and along the rear of vehicle just under rear window(s). If body is metal then the bus body shall be painted white to match cab; if body is FRP then the body shall be a high gloss gel coated white finish that matches the OEM Chassis Color.
- 35. **Placard**: Shall install a placard in a location clearly visible to the driver stating the maximum height restriction for the vehicle.
- 36. Protective body side moldings: Shall install a molding along each side of the vehicle's body locate at the floor line, if the body side panel is a two piece design. If the body side panel is a one-piece design then this molding is not necessary. Each molding should be approximately 2" to 3" wide, made of aluminum or other corrosive resistant metal and should incorporate a black plastic or vinyl insert and should run full-length horizontally where practical (may be omitted in areas such as doors, steps, and gas pockets).
- 37. <u>Radio</u>: Shall provide an AM/FM/CD with public address mode with four or more speakers installed in locations to provide uniform sound within the passenger area and a weather resistant external speaker. External speaker shall have a separate on/off switch.
- 38. **Rear Axle**: Manufacturer to select axle ratio, which will provide the best overall performance, and of the heaviest duty available.
- 39. **Running Board**: Shall provide a heavy gauge running board step on the driver's side to allow ease of access to cab area **and a heavy duty mud flap on front passenger side.**
- 40. **Rust proofing**: Shall be the highest quality available and be applied to entire area of underbody including wheel wells.
- 41. **Seat. Driver's:** Shall be an OEM high back seat or an approved equal with upholstery to match rear seats.
- 42. <u>Seats. Passenger</u>: All Vehicles, no matter what seating configuration, shall have at a minimum, three seat positions that accommodate infant seats with three-point child restraint system (CRS). Seating shall be Freedman GO Seat ES or approved equal. Seats

must meet or exceed all applicable Federal Motor Vehicle Safety Standards including FMVSS 207 and 210. Seating system must be tested in vehicle at an A2LA accredited lab to insure compliance to aforementioned standards. Double passenger seats must be minimum 35" wide, the cushion depth shall be 16" minimum and the cushion height above the floor shall be 17.5" minimum, 19.5" maximum. Back cushion height shall be "mid hi" and must be minimum 24" from the top of the seat cushion. Seat frame must be convertible to accept Child Restraint System (CRS-225) with LATCH hooks (Rigid & Recliner variations only). Child Restraint System (CRS-225) LATCH hooks must also be available as an option on foldaway seats. All ambulatory seats must be mechanically fastened to the base frame utilizing a U-bolt based system that allows for easy removal/installation (not applicable to flip or foldaway seats). All ambulatory seats shall utilize a UHSS (ultra-high strength steel) leg. Seats must be designed to allow for the addition of accessories without being removed from the base frame. These accessories include grab rails and flip up US arm rests. Seat bottom covers are to be easily removable from the cushions without removing seats from the base frame. All covers shall use a plastic extruded "arrow in trench" system to fasten covers to the seating system and must not require the use of any specialized tools or equipment to replace or remove. All seat cushions must be attached to the seat frame through the use of the Lock-N-GO (or equivalent) system to allow for easy removal and replacement. Seats cushions shall also have the option of being mechanically fastened to the seat frame. All foam cushions must meet or exceed FMVSS 302. All foam cushions must be molded polyurethane to ensure maximum individual passenger comfort and durability. All exposed metal parts and surfaces must be chemically cleaned and powder coated black to provide a rugged, long lasting, rust and corrosion resistant finish. Bench style seats and backs are not permitted, unless it is an optional foldaway type seat but must give the appearance of individual bucket seats. **Upholstery** material shall be a minimum CMI Level 3.5 Medallion Keops Azul Blue or an approved equal. Colors shall blend with the OEM interior colors. All seats shall be FMVSS 225 compliant and shall secure either a passenger or a child safety seat. Minimum hip to knee room on transverse mounted seats shall be 26" unless otherwise approved. Aisle width may vary according to seating configuration with a minimum of 10".

- 43. <u>Seat Belts</u>: Seat frame must have a 3 point shoulder belt. All seats belts shall meet or exceed FMVSS 209 and 210. A premium web cutter shall be supplied with each vehicle and shall be mounted in a highly visible location in the driver's area and have a label stating "Seat Belt and Wheel Chair Securement Belt Cutter".
- 44. <u>Seat Rails</u>: Shall be designed into the floor shall not extend beyond the last fixed seat on either side. At no point will the seat rail extend into an area designated as a wheelchair securement area.
- 45. <u>Seating Capacity</u>: Shall have a standard seating capacity for ambulatory passengers in a non-ADA equipped design to accommodate 17 passengers including the driver in the minimum 20' length unit. Shall include non-ADA equipped design to accommodate 21 passengers including driver in the minimum 22' length unit and 25 passenger including driver in the minimum 24' length unit. Seating capacity in units ordered with ADA wheelchair equipment may vary according to selected ADA options and seating options. <u>Seating diagrams depicting the manufacturers various offerings in both non-ADA equipped and a ADA equipped units to meet the required specifications shall be submitted with each bid and shall include a weight analysis.</u>
- 46. **Suspension**: Shall be load rated and the heaviest duty available for the GVWR of the vehicle provided. Stabilizer bars shall be provided on the front and rear axles. Rear suspension must accommodate any increased load capacity of an optional lift.
- 47. <u>Tires and Wheels</u>: Shall be the OEM's premium tubeless all-season radials rated for the size and GVWR to include a spare tire and wheel of the same OEM type. All wheels shall be painted to match the exterior color of the vehicle. If the spare tire is not mounted, via a frame

- mounting, then it must be placed on cardboard to prevent damaging the floor covering during transport to the agency.
- 48. <u>Transmission</u>: Automatic with a minimum of six (6) forward speeds and one (1) reverse, equipped with auxiliary transmission oil cooler and have an <u>external heavy duty backup alarm</u> controlled by transmission shift control in the reverse position.
- 49. Wheel well Housing. Rear: Shall be no less than 16-gauge steel or equivalent gauge aluminum.
- 50. **Windshield wipers**: Intermittent.
- 51. <u>Windows</u>: Sash and glass side windows, shall be <u>Kinro 8700 Series or Cleer Vision CT Series</u> windows or approved equal, shall be the horizontal top sliding type equipped with latches. All glass shall be tinted color smoke gray, darkest available according to OEM standard and specifications: or no less than 30% light transmitting. Emergency exits shall be provided at a minimum of one on each side of vehicle as a one-hinged escape window and shall be designed and installed in compliance with FMVSS 217.
- 52. **Wiring**: Body wiring harness shall have color, function, and number coded wire. All wiring harnesses shall be tested prior to installation inside the body and shall be inspected after installation to assure electrical systems and lights are functioning properly.

#### B. Options:

- A. Wheelchair Lift, 1.000 lb. Capacity: Shall offer a 1,000 lb. capacity wheelchair lift mounted aft of the rear axle on the right (curb) side with an Intermotive interlock system or approved equal. Lift must be fully compliant with all ADA and FMVSS requirements and specifications. Shall be a Braun or approved equal. Shall have safety belt mounted to the standee handrails to ensure that wheelchair passenger does not fall forward when lift is in the lift or deploy stages. Shall be a DOT public use lift. Lift shall have the pump on the front side of lift to provide ease of access for maintenance. Shall be FMVSS 403 and 404 compliant. Shall provide a door to access the lift mechanism, type and design typically provided by the manufacturer as approved by the OEM and have a restraint system for when the doors are in their open position. ADA decals shall be affixed to the lift and to the outside side and rear of the vehicle.
- B. Wheelchair Restraint System: Belt restraint systems shall be a premium model complete wheelchair and occupant securement systems designed for endurance and ease of use. All wheel chair tie downs shall have self-tensioning retractors and the lap/shoulder belts shall have retractors. Securement systems shall be Q-Straint, Sure-Lock or approved equal. Securement system shall be a full width L-track kit or approved equal. Shall have a minimum measurement of 44" from center of L-track to center of L-track. If the shoulder belt is above 60" then shall have a height adjuster for satisfactory securement and comfort for the occupant. A storage pouch for each system, designed to accommodate restraint belts, shall be constructed from commercial type heavy duty reinforced vinyl/cloth type material affixed to the inside of the vehicle in a location easily accessible and does not interfere with passenger comfort or seating placement. Shall be compliant with all ADA requirements and specifications.
- C. **Bumper**: Shall offer a Romeo RIM help rear bumper, or an approved equal.
- D. <u>Child Reminder System</u>: Shall offer a child reminder system, **Bus Scan 300** Series or approved equal, which requires the driver to perform an inspection of the passenger compartment before leaving the vehicle.

- E. <u>Destination Signs</u>: Shall offer a, Luminator TwinVision ALL LED or an approved equal, electronically controlled LED front sign and LED side sign destination sign system and shall not include programming software and PCMIA card.
- F. Floor Covering: Shall offer as an upgrade a transit grade Altro vinyl with a minimum 1/8" thickness and shall be color keyed to the interior and seats.
- G. <u>Raised Floor</u>: Shall offer a raised floor installed in such a way as to eliminate rear wheel pockets that will maximize the wheelchair placement area when more than two rear wheelchair stations are required.
- H. <u>Seats. Foldaway</u>: Shall offer a Freedman GO Seat ES Foldaway seat or approved equal. Foldaway seating shall meet the same requirements as the standard fixed seats. The seat must be cantilevered and must not require an aisle leg or tether for support. The foldaway seat must require no more than 3 operations to either store or deploy. In the stored position, the foldaway seat must be less than 13" wide. All foldaway seats must match the visual and functional design of the other seats in the bus.
- I. <u>Seats</u>: Shall offer additional seats, which accommodate infant seats with three point Child Restraint System (CRS).
- J. <u>Seat Belt Extensions</u>: Shall offer as an option seat belt extensions for all passengers.
- K. <u>Suspension. Rear</u>: Shall offer a Mor/Ryde or approved equal suspension enhancement system.
- L. <u>Upholstery: Fabric upgrade</u>: Shall offer as an upgrade the CMI Level 4 Plush Series or an approved equal in Incense Blue color.
- M. <u>Upholstery: Vinyl upgrade</u>: Shall offer as an upgrade the CMI Level 4 Dimensions Nanocide Vinyl or an approved equal in Late Evening or Charcoal color.
- N. <u>Vent. Safety</u>: Shall offer a combination ventilator and safety exit generally used on transit buses and shall be a Transpec dual-purpose heavy-duty model or an approved equal.
- L. <u>Personal Protection Equipment</u>: Shall offer as a COVID-19 protective equipment to help protect passengers against the spread of germs and airborne viruses. Shall be Freedman or approved equals. Options will include:

**Passenger Sneeze Guards**, made from a flexible material that does not present a laceration hazard or hard impact surface but is also UV and mildew resistant;

- Item 1: Stationary sneeze guard for non-flip seat
- Item 2: Pivot type sneeze guard for flip seat
- Item 3: **Social Distance Seat Bands** to block passengers from sitting on designated seats, made of a durable, flat-woven fabric that is anti-microbial and moisture repellent;
- Item 4: **Grab Rail Covers** from Dimensions Nanocide vinyl with embedded silver, a natural antimicrobial, that are easy to add or replace in the field.

#### TERMS, CONDITIONS, AND PROVISIONS

All Bidders will adhere to the following terms, conditions, and provisions:

**Legal Requirements:** Bidders must possess, and be in compliance with, all local, state, and federal licensing and other legal requirements for the distribution and/or sales of the motor vehicles and other products proposed; and, shall submit a <u>copy of the **Arkansas Dealers License**, Buy America documentation, and Bus Manufacturer's Certification or other documentation as may be required.</u>

Signatures: All bidders must complete the Bid Quotation Form by providing all required. Each page of the Appendix A and B must be initialed and returned with the bid quotation. The Required Federal Certifications and Contractual Provisions (Appendix B) must be executed by completing and signing the last page in ink and be attested by a Notary Public.

**Specification Detail:** All bidders must provide the manufacturer's specifications in sufficient detail to determine compliance with all specifications set-forth in the advertisement for bids for chassis, body and accessories. The bidder must provide floor plan drawings of the proposed vehicle-seating configuration and weight analysis.

Warranty and Service Center: <u>All bidders must have</u>, and identify, a warranty and service location in <u>Arkansas</u> and staffed with factory trained personnel for all vehicles and major component equipment proposed. Further, the bidder must be able to perform, or have performed warranty and service on all items not covered by original equipment manufacturer's warranty. Any such facility must have an adequate supply of parts to cover vehicle body components and related equipment (i.e., windows, seats, electrical system and lights, air conditioning, wheelchair lifts and tiedown equipment).

A letter of non-acceptance or a Motor Vehicle Report will furnish details of the deficiencies.

**Delivery:** Bid prices shall include delivery of all vehicles to the Arkansas Department of Transportation (Department) at the following F.O.B. location, 10324 I-30, Little Rock, Arkansas, and shall include the regular warranty, any Arkansas motor vehicle safety inspection required and service regularly furnished on new vehicles sold to the public. Delivery shall be determined by signed receipt of the Department's designated representative at the point of delivery indicated above and may be preceded by an inspection of the unit. **Delay in Delivery:** In the event of delivery of completed transit vehicle purchased under this contract shall be necessarily delayed because of strike, injunctions, government controls, weather, or by reason of any other cause or circumstance beyond the control of the Bidder, the time of completion of delivery shall be extended by mutual agreement between the Department and the Bidder.

Demonstration: <u>The Department reserves the right to test drive make and model of vehicles bid on prior</u> to a contract being awarded. Samples may be demonstrator models with equipment similar, but not necessarily identical, to that listed in this specification.

**Federal Register Standard:** Any equipment furnished on a vehicle purchased under this specification for which "Federal Register Standard" has been established at time of delivery shall comply with the requirements of applicable standard and all equipment required by said standard shall be furnished whether or not it is specifically mentioned in this specification.

**Operator's Manual:** The successful bidder shall furnish copy of Operator's Manual published by vehicle manufacturer with each vehicle delivered.

**Advertisements:** No dealer advertisement shall be affixed to the vehicle.

**Serviced:** Each vehicle shall be completely serviced, cleaned and thoroughly inspected (in accordance with manufacturer's required or recommended pre-delivery service) just prior to delivery to the Department.

**Vehicle OEM Warranty** - The successful bidder shall not allow any contractors/manufacturers to perform any manufacturing process, component installation, or take any other action which will violate or otherwise cause the vehicle OEM to withdraw their full and complete warranty.

**Warranties:** The successful bidder shall furnish all warranty data for each vehicle delivered, as well as any warranty data for non-OEM components installed. The warranty data shall contain all necessary information such as make, model, serial number, etc., and shall be appropriately executed and assigned at the time vehicle is delivered to the Department.

**Bidder Review Procedures:** All sections of this IFB and all supplementary documents are essential parts of the bid award and performance contract and requirements occurring in one or as though occurring in all. **Interpretation, Changes, and Modifications:** Any interpretation, change, or modification made to the specifications by the Department will be made only by a written addendum. A copy of such addendum will be mailed or delivered to each bidder receiving a set of documents and shall be applicable to all respective bidders.

**Addenda:** Addenda issued by the Department prior to the bid opening shall be binding as if written into the original IFB.

The Bidder agrees to maintain all books, records, accounts and reports required under this contract for a period of not less than three years after the date of termination or expiration of this contract, except in the event of litigation or settlement of claims arising from the performance of this contract, in which case the Bidder agrees to maintain same until the Department, the FTA Administrator, the Comptroller General, or any of their duly authorized representatives, have disposed of all such litigation, appeals, claims or exceptions related thereto. Reference 49 CFR 18.39(I)(11).

**No Obligation by the Federal Government**: The Department and Bidder acknowledge and agree that, notwithstanding any concurrence by the Federal Government in or approval of the solicitation or award of this bid, absent the express written consent by the Federal Government, the Federal Government is not a party to this contract and shall not be subject to any obligations or liabilities to the Department, Bidder, or any other party (whether or not a party to that contract) pertaining to any matter resulting from the award of this bid.
