**1. NOTICE TO THE GENERAL CONTRACTORS**

Sealed bids for the **HWY. 70/ HWY. 391 IMPROVEMENTS (NORTH LITTLE ROCK) (S)** will be received by the City of North Little Rock, at **10:00am, March 12, 2021**, at 120 Main Street, North Little Rock, Arkansas and then be publicly opened and read aloud. Any bids not submitted on time will be returned unopened.

**2. SCOPE OF WORK**

a. The Contractor shall complete all work as specified or indicated in the Contract Documents. The work is generally described as follows: State Highway Improvements associated with the new Amazon Facility being constructed in the vicinity of State Highway 70 & Highway 391. Project involves the following:

1. Roadway Improvements (Approximately .7 Miles) along State Hwy. 70.
2. Roadway Intersection Improvements at State Hwy. 70/ Hwy. 391.
3. New Concrete Retaining Walls at locations along State Hwy. 70.
4. New Traffic Signal furnished, installed (constructed) and tested at State Hwy. 70/ Hwy. 391.

**3. SINGLE PROPOSAL**

Bidders shall submit one proposal for the entire project.
