Notice is hereby given that the City of Bella Vista, Arkansas (City) is seeking letters of interest from qualified consulting firms for the design of the expansion of Mercy Way bridge and corridor improvements from U.S. Highway 71 to Dartmoor Road in Bella Vista, Arkansas.

The work will generally consist of providing surveys, environmental studies, geotechnical studies, hydraulic studies, roadway and bridge design and plans, and right of way plans. This project includes federal-aid funds and all work will be reviewed and approved by the Arkansas State Highway and Transportation Department (AHTD). All work and contract requirements shall conform to requirements of the Federal Highway Administration, AHTD and the City.
