REQUEST FOR LETTERS OF INTEREST -- Notice is hereby given that Metroplan is seeking letters of interest from qualified consulting firms for on-call services for the design and construction engineering and inspection of agency-sponsored Transportation Improvement Program (TIP) projects. The contract will include technical task directly related to the state and federal aid requirements for transportation projects that includes but is not limited to design, land surveys, environmental documents, bridge plans and hydraulic information, geotechnical studies, right-of-way, utility coordination and construction inspection. The initial contract period for selected firms will be for 3-years and may be extended to a max of 5 years. Submittals must be received by Metroplan; 501 W. REQUEST FOR LETTERS OF INTEREST

Notice is hereby given that Metroplan, the Metropolitan Planning Organization (MPO) for the Central Arkansas Regional Transportation Study (CARTS), is seeking letters of interest from qualified consulting firms to perform design and construction engineering and inspection services on an on-call basis for agency sponsored projects. The initial contract period for selected firms will be for 3-years and may be extended to a max of 5 years. The work will include one or more of the following tasks for each project:

- Control, Design, and Land Surveys as necessary to complete the project as assigned;
- Documentation for Environmental Clearance;
- Environmental compliance surveys;
- Design and plans;
- Bridge design and plans, including necessary hydrologic and hydraulic information;
- Geotechnical studies;
- Right of Way plans;
- Utility coordination; and
- Construction Engineering and Inspection.

Background

Metroplan is responsible for implementing its Long-Range Metropolitan Transportation Plan (LRMTP) through its Transportation Improvement Program (TIP). Projects funded by Metroplan include roadway, bicycle, pedestrian and transit facilities. To streamline the implementation of Metroplan's TIP projects, the organization is pursuing long-term on-call contracts with up to four (4) qualified consultant firms to provide various engineering services.

Candidates should be experienced in managing engineering and project management efforts on Federally funded projects. Firms should have a clear understanding of industry best practices found in publications such as the *MUTCD*, *AASHTO Green Book*, *AASHTO Bicycle and Pedestrian Guidelines*, and *NACTO Urban Street Design Guide* and should be familiar with Metroplan's current LRMTP and CARTS standards for multi-modal facilities. Public and stakeholder engagement is a priority on all Metroplan projects. Qualified candidates should have experience engaging MPOs, State DOTs, local elected officials, and the public.

One (1) electronic copy in pdf format must be received no later than **11:00 a.m. CDT, Monday, December 14, 2020**. Submittals may be sent via email to ccovington@metroplan.org or provided on a thumb drive to the address listed above. Any response received after this deadline will not be considered.

After a review of letters of interest received, qualified firms will be furnished a scope of work and requested to submit proposals for accomplishing the work. Consultants will be selected following review of proposals. Work is then expected to begin on or about March 1, 2021.

Projects will be assigned based on the needs and requirements of individual projects, staff availability and current workload, expertise of firm and prior experience with similar projects. Selected firms will be assigned work in the form of a task order and asked to draft a cost estimate and schedule for the proposed work. Metroplan and its governing board will evaluate and negotiate proposed fees and schedules for services before executing a task order. Assigned work may not be distributed equally among selected firms.

SELECTION PROCEDURE

Metroplan's objective is to select the highest qualified firms for the services to be rendered. To accomplish this objective, respondents will be evaluated in a two-phase process. In the first phase the Letters of Interest will be evaluated to determine firms deemed to be most highly qualified, responsive, and responsible to provide the services. In the second phase (RFP), these short listed firms will be provided a scope of work from which to prepare a proposal.

A Consultant Qualification Review Selection Committee appointed by Metroplan will use the following criteria to evaluate respondent's Letters of Interest submittals.

Part 1 – Letter of Interest Criteria

| No. | Evaluation Factors for LOIs | Maximum Points Possible |
|----------------------|---|-------------------------|
| 1 | Professional staff including education, experience, availability, and any partnerships with sub-consultants | 10 |
| 2 | General and professional reputation, including responsiveness to civil rights and equal employment opportunity requirements and opportunities | 10 |
| 3 | *Past work performance, particularly on federal aid projects | 10 |
| 4 | Experience with projects of a similar nature as those advertised | 10 |
| Total Points for LOI | | 40 |

*Past work performance or evaluations from other clients will be considered when the firm has not worked for the Local Agency previously.

Each member of the Committee will assign up to the maximum points noted above to each criterion based on respondent submittals. Respondents will then be ranked according to their total cumulative points. Based on this ranking, the Committee may conduct interviews, at their discretion, with representatives of the top ranked firms. From the top ranked firms, up to five (5) firms deemed to be qualified, responsive, and responsible to provide the services required will be short listed (minimum of 3).

In the **second phase** the short listed firms will be provided with a scope of work and requested to provide a proposal. The final selection will be based upon the scoring of both the qualifications and proposals of selected firms with up to four (4) firms selected to provide on-call services.
