### **Department Seeking Public Input about Proposed Widening of Highway 112 in Washington & Benton Counties**

**WASHINGTON & BENTON COUNTIES (12-10)** - The Arkansas Department of Transportation (ARDOT) will conduct an online public involvement meeting about the proposed widening of Highway 112 between Highways 412 and 612 through the cities of Tonitown, Springdale, and Elm Springs in Washington and Benton counties.

The public is invited to listen, view meeting materials, and provide written comments. The website will be available for comments until **4:30 p.m. on Friday, January 1**. Citizens will have an opportunity to ask questions and make comment during a “live” virtual presentation from **5:30 p.m. to 6:30 p.m. on Tuesday, December 15**.
