AHP Officer Places in Top Ten in International Competition

After being recognized as the Arkansas Highway Police (AHP) top inspector for the second consecutive year at the 2009 Arkansas Inspector Competition in Springdale this summer, PFC James Canard represented the AHP in the 2009 North American Inspector Championship (NAIC) recently held in Pittsburg, Pennsylvania.

At the NAIC, PFC Canard was recognized as a member of an eight-person "Top Team" that scored the highest combined average during the competition in each of the following inspection categories – North American Standard Level I Inspection, Level V Passenger Vehicle Inspection and HAZMAT/Transportation of Dangerous Goods Inspection. On an individual basis, PFC Canard finished ninth in the overall competition. More than forty inspectors from the United States, Canada and Mexico participated in the event.

The NAIC is sponsored by the Federal Motor Carrier Safety Administration and the Commercial Vehicle Safety Alliance and is held annually in conjunction with the American Trucking Association's National Truck Driving Championship. The NAIC is the only international event dedicated to recognizing and rewarding commercial vehicle inspector excellence.



T.J. Brown, of the Heavy Bridge Division, specializes in fretwork (l.) and intarsia (r.) methods of woodworking.

Brown grew up outside of Malvern in a small community named Gifford. He was 9 or 10 years old when he took an interest in woodworking.

"I was in the Cub Scouts and one of our projects was to build a little wall shelf," Brown recalls. "Being raised out in the country, I was always building tree houses and push cars."

When he got older, Brown got a job as a carpenter's helper.

"I started picking up cut-off boards and scraps to take home to try and build things."

When he was 20, he bought an old, worn out scroll saw and started to make little cut outs like rocking horses. His Dad bought him a new saw as a birthday present and he started trying to cut a style of woodworking called Fretwork.

"Fretwork is a flat piece of wood that you cut holes in to make a picture or a design," Brown comments. "I have had people tell me that it looks like a piece of lace."

"In 1996, I met a retired man that showed me what a really good quality scroll saw could do. I saved my money until I could buy one like his. That was 1997 and that's the same saw I use today."

All of Brown's works are done with a scroll saw. The Fretwork is self taught with advice from a friend every now and then.

In addition to Fretwork, Brown uses a style of woodworking called Intarsia.

"Intarsia is where you use different types of wood to get different colors and grains to make a 3D picture. You carefully cut and fit the different woods together and then shape them until you have the different heights and contours you want. No stains or paints are used, the colors you see are the natural colors of the wood."

To learn the Intarsia form of woodworking, Brown went to Pigeon Forge, Tennessee, and took a class from Judy Gale Roberts who was the world's most well known Intarsia artist in 2007 and 2008.

In addition to learning to create his works using his imagination and a saw, Brown has to consider the type of wood to use.

"I mill a lot of the native hardwoods I use, like oak and walnut, from logs people give me. It may be a tree that was knocked down by a storm or one they needed removed and they just didn't want to see it go to waste. I also buy exotic hardwoods from people all around the world to use for the bright colors you see in some of my work."

Brown devotes anywhere from 10 to 20 hours a week to woodworking. In a year's time he can produce 5 to 7 Intarsia pieces and 20 to 30 Fretwork pieces.

His work can be seen at his website, at local events such as the annual Malvern art show and local county fairs. In addition, he sells through three art galleries in Arkansas: The Jewel Box in Eureka Springs, The Fort Smith Art Center and Susy's Art and Framing in Fort Smith.

Prescott, Arkansas, is finally getting connected. Situated alongside one of Union Pacific Railroad's main lines, the city of Prescott will enjoy improved access across town once the work on the Highway 67 railroad overpass is completed next year. Due to the many trains that pass through Prescott each day, the citizens of Prescott have had to cope with delays and blocked access for years.

U.S. Congressman Mike Ross, a native of Prescott, was able to earmark \$2.8 million for this project in the federal highway bill that expires this month. Because of its urban setting and high visibility, the bridge substructure will be given an Ashlar stone finish and will be painted various shades of brown to enhance the beauty of the structure. The inset of the exterior side of the parapet walls will be painted light brown.

Earnest Investments, LLC was awarded the contract for \$6.2 million in November of 2008.
